Meredith opens the meeting with the Serenity Prayer.

New business is the first subject with elections as the first thing Meredith would like to cover.

Elections procedures as detailed in the POO should be conducted via secret ballot with a 30-day notice having been given to all Unity members. Logistics for today's elections are covered by Meredith. To meet the secret ballot requirement, votes will be cast via private message to Meredith.

Central Office Delegate is the first position up for nomination. To start, the current delegate, Casey Myers, provides a brief overview of the duties. Meredith asks for nominations. The first nominee is Mel A. (nominated by Mel A.). There are no other nominees suggested. In lieu of no contest, the secret ballot requirement is waived, and a visual show of hands is used. Mel A. is confirmed as the new delegate. Congratulations are given.

Group Chair is the next position to be decided. Continuous sobriety of at least 5 years is required. Meredith reads the rest of the description from the POO. Meredith adds her experience and shares she has tried to take as little decisive action as possible. From her perspective, the only job of the chair is to start and stop the business meetings on time. Emmet O. presents the first and only nomination of Eric K who promptly accepts. Again, a visual indication for approval is all that is requested of the group. Eric is confirmed as the next chairperson.

General Service Representative (GSR) is the next position to be filled. Meredith reads the role descriptions from the POO and asks for nominations. Eric K. nominates Erin B. for the role of GSR and Erin proceeds with her nomination speech. No other nominations are presented, and a visual vote is taken. Erin B. is the next GSR.

Grapevine and Accessibility Representative is the next. After the description is read from the POO by Meredith, nominations are presented. Blake nominates Jenna W., and she accepts. After a visual vote, Jenna W. is confirmed as the next Grapevine and Accessibility Representative.

H&I Representative is currently held by Liz G. Meredith reads the role's description and asks for nominations. Erin B. nominates Eric W. Eric accepts the nomination. Liz G. nominates Kris R. (Rool Host). Kris also accepts the nomination. After Kris's acceptance of his nomination, Eric W. asks to withdraw from the race. Kris R. is confirmed as the next H&I Representative.

Other new business includes a new face mask mandate from the church. Meredith shares that Unity Temple now requires face masks always in all locations inside the building. She also shares that there has been no opposition to this by attendees at the Temple.

A new safe is needed at Unity Temple as the current safe is no longer able to be opened. Erin B. has reached out to a locksmith and we will have more information on Monday. Discussion ensues around the possible outcomes from Monday. It comes to light that there is not a clear understanding of what is going to happen on Monday...

The Treasurer's Report is shared. Unity AA was "in the black" last month. There are more than enough funds to engage a professional to address the safe situation.

A motion passes to approve that Erin B. set up a consultation with a locksmith and make a choice as to the next appropriate action (repair or replace).
